



Kanke, Ranchi, paying @ Rs. 200/- per schedule up to 07.05.10 against request in writing in printed letter head of the contractor, Mill Owner, Wholesale dealer etc.
- (b) Complete tender forms should be sent by registered post or by hand to the Administrative Officer, C.I.P., Kanke, Ranchi-6 in two envelopes, one containing proof of registration of JST and Central Excise, latest income tax clearance certificate and attested photocopy of the credentials like wholesale dealership license, manufacturer license etc. along with the required Earnest Money superscribed "Technical Bid" and another containing rates of the items in prescribed schedules superscribed "Price Bid". The sample to be submitted in transparent sealed polythene packed with inside slip should be submitted in the office of Administrative Officer, C.I.P., Kanke, Ranchi on or before 03.00 P.M. on 21.05.10.
- (c) The undersigned reserves the right to accept or reject any or all tenders and to auction the lowest tender or not to accept the lowest tender or withdrawing any schedule item. Tender received late will not be accepted. The fresh earnest money is to be submitted along with tender paper in the form of Term Deposit Receipt of any Nationalized Bank or Bank Guarantee pledged to Administrative Officer, C.I.P., Kanke, Ranchi-6. Bank Drafts, Cheque, Banker's Cheque are not acceptable. Carry forward of old security money will not be accepted. On the top of the envelope containing tender paper the amount of earnest money enclosed should be clearly written, failing which the tender will not be accepted and will be returned to the tenderer. The envelope containing Technical Bid envelop and Price Bid envelop should be superscribed "TENDER FOR DIETARY ARTICLES" DUE ON 21.05.10.
- (d) In case technically not qualified, the unopened price bid will be returned to the tenderer
