WALK IN INTERVIEW

Applications on plain paper either typed or handwritten along with two passport size photograph, photocopy of the certificates of educational qualification, experience etc., may be submitted to the undersigned before **28.04.2018**. After submission of application candidates have to turn up alongwith their original certificates on the date of interview. No interview letter will be issued separately. In deserving cases age and experience criteria may be relaxed and even retired person upto the age of 62 years may be allowed to appear for interview. Experience in private sector may also be considered.

The interview shall be held at Central Institute of Psychiatry, Kanke, Ranchi-834006, Jharkhand, on 28.04.2018 at 09.30 a.m.

I. Essential Qualification for posts at Sl. No. 1, 2, 3, 4 & 5 (Asst. Prof. of Psychiatry, Neurology, Neurosurgery, Anaesthesiology and Radio-diagnosis.

- (i) A recognized MBBS degree qualification included in the First or Second Schedule or Part II of the Third Schedule (other than licentiate qualifications) to the Indian Medical Council Act, 1956 (102 of 1956). Holders of educational qualifications included in Part II of the Third Schedule should also fulfill the conditions specified in sub-section (3) of section 13 of the Indian Medical Council Act, 1956 (102 of 1956).
- (ii) Post-graduate degree in the concerned Speciality or Super-speciality mentioned in Section –A of Schedule-VI,

- (iii) At least three years' teaching experience as Senior Resident or Tutor or Demonstrator or Registrar in the concerned Speciality or Super-speciality in a recognized teaching institution after obtaining the first Post-graduate degree qualification.

(The essential teaching experience may be relaxed from 3 years to 1 in the concerned Speciality or Super-speciality as Senior Resident or Tutor or Demonstrator or Registrar after obtaining the first Post-graduate degree qualification at the discretion of the Selection Committee if a person is found otherwise suitable).

II. Essential Qualification for posts at Sl. No. 6 (Assoc. Prof. of Clinical Psychology)

1. Masters Degree in Psychology of a recognized University or equivalent.
2. M.Phil (Medical & Social Psychology or Clinical Psychology) or Diploma in Medical & Social Psychology (2 years course) from a recognized Institution or equivalent.
3. Doctorate Degree (Ph.D.) in Clinical Psychology from a recognized university or equivalent.
4. 4 years teaching/research experience (including at least 2 years as Asst. Prof. of Clinical Psychology)

(The essential experience shall be relaxed from 4 years to 2 years as Asst. Professor of Clinical Psychology at the discretion of Selection Committee if a person is found otherwise suitable).

Desirable: Research/published work in Indexed journals.

III. Essential Qualification for posts at Sl. No. 7 (Assoc. Prof. of Psychiatric Social Work)

1. Masters Degree in Social Work/Sociology from a recognized University or equivalent.
2. M.Phil or Diploma in Psychiatric Social Work (2 years course) from a recognized Institution or equivalent.
3. Doctorate Degree (Ph.D.) in Psychiatric Social Work from a recognized university of equivalent.
4. 5 year teaching/research experience (including at least 2 years as Asst. Prof. of Psychiatric Social Work) in a recognized Institution.

(The essential experience shall be relaxed from 5 years to 2 years as Asst. Professor of Psychiatric Social Work at the discretion of Selection Committee if a person is found otherwise suitable).

Desirable:

- (I) Degree or Diploma in Anthropology, Social Psychology, Sociology or Statistics.
- (II) Experience in Psychotherapy and Counselling techniques.

IV. Essential Qualification for posts at Sl. No. 8 (Asst. Prof. of Clinical Psychology)

1. Masters Degree in Psychology of a recognized University or equivalent.
2. M.Phil (Medical & Social Psychology or Clinical Psychology) or Diploma in Medical & Social Psychology (2 years course) from a recognized Institution or equivalent.
3. 2 years teaching/research experience as Clinical Psychologist in a Psychiatric Hospital, Psychiatric Clinic, Child Guidance Clinic or Department of Psychiatry in a General Hospital.

(The essential 2 years teaching/research experience as Clinical Psychologist in a Psychiatric Hospital, Psychiatric Clinic, Child Guidance Clinic or Department of Psychiatry in a General Hospital may be relaxed to no experience as essential qualification at the discretion of Selection Committee if a person is found otherwise suitable).

- Desirable:**
1. Ph.D in Clinical Psychology.
 2. Research/published work in Indexed journals.

V. Essential Qualification for posts at Sl. No. 9 (Asst. Prof. of Psychiatric Social Work)

1. Master/s Degree in Social Work / Sociology / Applied Sociology from a recognized University or equivalent.
2. Diploma or M.Phil in Psychiatric Social Work from a recognized Institution.
3. 2 years teaching/research experience as a Psychiatric Social Worker in a Mental Hospital, Child Guidance Clinic or Psychiatric Department of a General Hospital.

(The essential 2 years teaching/research experience as a Psychiatric Social Worker in a Mental Hospital, Child Guidance Clinic or Psychiatric Department of a General Hospital shall be relaxed to no experience as essential qualification at the discretion of the Selection Committee if a person is found otherwise suitable).
